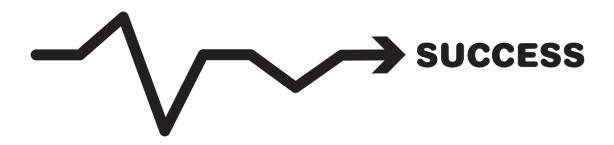

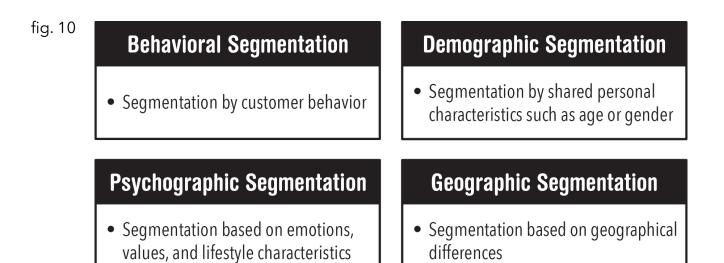


fig. 11 Methods of B2C Customer Segmentation

4 Cs Model

A service-focused alternative to the 4 Ps of Marketing model. The four Cs represent the marketing mix for service businesses. Product translates to Customer Solution, Price to Customer Cost, Promotion to Customer Communication, and Place to Customer Convenience.

4 Ps of Marketing

The standard marketing mix. Together, Product, Price, Promotion, and Place form a high-level overview of the considerations that marketers must make when crafting a marketing plan. Different products have a different mix of spending and focus on each of the four Ps.

Barriers to Entry

Obstacles that prevent new ventures from entering and participating in an industry. These obstacles could include prohibitively expensive initial costs, pressure from entrenched firms within the industry, or restrictive government regulation.

Brand Collateral

The various digital and physical elements that make up your brand. These include a company's logo, brand color palette, website, business cards, and other branded elements.

Break-Even Point

The point at which costs equal revenue. At this point, a business can begin to turn a profit.

Burn Rate

The negative cash flow that a startup experiences while covering startup expenses before the venture becomes profitable, or at least produces enough revenue to sustain itself.

Business Model

A strategic design that outlines the method by which a business profitably solves a problem for specific customers. A successful business model acts as a template that includes considerations for operational, technical, and financial aspects of the business.

Competitive Advantage

The sum of conditions that put one business in a superior or favorable position over another. Competitive advantage stems from resources, competencies, or capabilities that are valuable to the customer, rare, not easily imitated, and not easily substituted.

Customer Avatar

A fictional profile that represents the qualities that your perfect customer would exhibit. This customer persona is designed to guide efforts to identify the target market for a product or service, as well as to refine marketing efforts.

Dilution

The devaluation of every member of a founding team's equity when a new member joins the team. Because total ownership of equity in a venture cannot exceed 100 percent, when a new equitysharing member claims a portion, every other portion becomes smaller.

Direct Competitors

Competitors who compete in a one-toone capacity. These firms offer the same solution to a customer's problem, for example, two pizza shops in the same neighborhood. The customer problem is hunger—a problem for which there are many solutions—and two pizza shops offer the same solution.

Distinctive Competencies

The source of competitive advantage. Distinctive competencies are a combination of best practices and technical skills that come together in a valuable and creative way that is difficult to beat by competitors.

Due Diligence

The comprehensive, specific, and often technical questions that investors ask entrepreneurs regarding the nature of their startup. It is important that these questions be answered truthfully and as accurately as possible, as the answers are material to investor decisions about whether to invest in a venture or not.

Effectuation

The opposite of causation. Instead of starting with a goal and gathering resources to accomplish that goal, effectuation is the process of developing a goal based on the resources at hand.

Foreign Qualification

The practice of registering a business in a state where it is not physically based.

Entity Classification

The legal form of a business. Different legal forms offer different advantages in the form of personal liability protection, tax liability advantages, and methods of acquiring capital.

Entrepreneurial Thumbprint

The unique blend of background, talent, insight, and perspective that positions an entrepreneur to turn an idea into an opportunity.

Flow

A state of elevated focus and elation that stems from a match of competency and challenge for a particular task. Learning and productivity are maximized when a flow state is achieved, along with a feeling of accomplishment.

Gantt Chart

A visual representation of a project or series of milestones. This type of chart is especially useful to demonstrate a sequence of dependent tasks.

Graphic Identity

The sum of a business's visual elements such as logos, business cards, visual messaging elements, color palette, and visual themes.

Indirect Competitors

Competitors who offer a different solution to the same customer problem. For example, a pizza shop and a sandwich shop both solve the problem of hunger, but they offer different solutions. Both establishments indirectly compete with grocery stores and other restaurants as well—other businesses that help customers solve the same problem but offer different solutions.

Kaizen

A philosophy of continuous improvement. Kaizen favors constant incremental change that can be implemented immediately and with minimum disruption over large sweeping changes that can often cause disruption. In addition to being an engine for improvement, the philosophy of kaizen teaches practitioners to embrace change—a critical mentality for entrepreneurs.

Liquidity Event

An exit strategy that transforms equity into cash. Common liquidity events include acquisitions, mergers, and initial public offerings (IPOs).

Marketing Collateral

All the sales sheets, brochures, articles, and case studies that are used to promote a brand, product, or service.

Marketing Mix

Elements of the exchange that exists between a brand and its customers. Traditionally, the marketing mix is made up of four key elements collectively referred to as the "4 Ps": product, price, promotion, and place.

Outsourcing

The process of relying on third-party firms to carry out processes that do not directly contribute to a venture's value chain. Outsourcing plays a critical role in the development of many startups and is cheaper and easier than ever before.

Porter's Five Forces

A conceptual framework designed to help business decision makers better understand the ways in which the pressures of competition influence an industry or industrial sector. The five forces are the intensity of competition within an industry, the bargaining power of suppliers, the bargaining power of buyers, the threat of substitute products, and the threat of new industry entrants.

Price Ceiling

The highest price a firm can charge for its product or, effectively, the highest price the market will bear.

Price Floor

The lowest price a firm can charge for its product while maintaining a profitable margin.

Price Sensitivity

The degree to which price factors into the buying decisions of a market segment. A high sensitivity to price means that low or affordable prices are very important. Low price sensitivity means that other product features are more important than price.

Primary Activities

The operational activities in a value chain that contribute directly to the creation of value for customers. In a value chain analysis, these activities include inputs, operations, distribution, marketing, and service.

Promotional Mix

The combination of various forms of promotion that are particular to a product or service. The promotional mix consists of advertising, public relations, personal selling, and sales promotion.

Runway

The amount of time a venture can stay in business before its burn rate surpasses the amount of cash it has raised.

Sales Cycle

The process that a firm undergoes from the initiation of a sale to the close of that sale.

Sensitivity Analysis

An exploration of the impact particular variables have on a forecasted outcome. These analyses are used to gauge how reliable a plan is and what vulnerabilities it may have.

Shiny Object Syndrome

The practice of adjusting focus and shifting a plan to accommodate the newest, flashiest tools. It is important to be ready to pivot when the situation calls for it, but constantly adopting new systems results in wasted energy and spinning wheels.

SMART

An acronym that stands for specific, measurable, achievable, relevant, and time-bound. These qualities represent a best practice for effective goal setting. Vague, unrealistic, or open-ended goals are not only unlikely to be accomplished but represent a lack of focus and strategy.

Support Activities

Activities within a value chain that indirectly add value. These include areas of a firm such as financial and legal, human resources, development, and procurement.

Top-Level Domain

The suffix of a web address. Common toplevel domains include .com, .org, .info, .edu, and .gov.

Value Chain

The journey that a firm's inputs take through operational processes. This journey transforms them from raw materials into outputs that have value for the firm's customers. All firms have a value chain, but the specifics will vary from firm to firm (even within the same industry).

Value Proposition

The why of a venture. It is the answer to two key questions: who is your target customer and how are you different from your competition? A venture's value proposition is at the heart of its success.

WAG

An acronym for the phrase "wild-ass guess." Your business plan should have as few of these as possible, although your audience will understand that certain elements of your plan will be an educated guess out of necessity.
